§ 1 Rental Property

1.1. The Bonn Student Association is renting to the lessee the

- 1.2. Rented items/furniture are listed in a separate condition report/inventory list which is an essential part of this rental contract.
- 1.3. The rooms and facilities may be used communally in accordance with their respective intended purpose and the provisions of the House Rules.

§ 2 Duration of the Rental Agreement

- 2.1. The regular agreement begins on <u>DD.MM.YYYY</u> and ends on <u>DD.MM.YYYY</u> and does not require a specific termination notice.
- 2.2. However, if the lessee continues to use the rental property after expiration of the rental contract, be lease is not considered to be extended. Section 545 of the German Civil Code (BGB) is not applicable.
- 2.3. In exceptional cases, the rental agreement can be terminated by the tenant before the end of the contractual period. In this case the termination must be declared in writing form not later than the 3rd working day of a calendar month to the end of the month. The date that the lessor receives the termination notice is decisive for observing the deadline.
