Notes on and terms and conditions of the *Deutschlandstipendium* scholarship

The University of Bonn Foundation undertakes:

- a) To only use the donation for the purposes of the *Deutschlandstipendium* scholarship in accordance with the Scholarship Program Act (StipG) and the Ordinance Implementing the Scholarship Program Act (StipV) and to take the wishes of the person funding the scholarship into account as far as possible while complying with the statutory provisions
- b) In accordance with the applicable provisions, to select students who are in line for outstanding achievements in their studies or professional life based on their progress to date
- c) To pay out scholarships in monthly installments, to review the study progress of scholarship recipients annually and to conduct regular evaluations in accordance with the applicable regulations of the *Deutschlandstipendium* scholarship program
- d) To issue donation receipts once a calendar year for the amounts donated
- e) To establish personal contact with scholarship recipients if they give their consent, which we shall seek to obtain via a corresponding declaration

The donor undertakes to pay the amount stated overleaf by bank transfer.

Terminating studies early

If a scholarship recipient terminates their studies early, the donor agrees that the amounts that they have already donated will be allocated as *Deutschlandstipendium* scholarships to other University of Bonn students following a consultation and in line with the selection process. The donor is aware that, in accordance with §6 para. 3 in conjunction with §8 sentence 2 of the Scholarship Program Act (StipG), the University of Bonn shall be obligated to continue paying out the scholarship until the end of the semester if scholarship recipients move to study elsewhere during the funding period. The donor hereby gives their consent to this.

Contact and consent to the use of data

In order to implement the national scholarship program, the University of Bonn is obligated to find out the legal form of funding providers, information on ring-fencing donated funds for specific degree programs and the total amount of funds donated in order to maintain a set of nationwide statistics (§13 StipG).

2. Collection and storage of personal data, type and purpose, and use of the data

Your data that is entrusted to us will only be used in connection with the *Deutschlandstipendium* scholarship and will be kept confidential. We will use your data to put the funding agreement in place, to send invitations to meetings of scholarship recipients and University of Bonn Foundation events, and to send information about the University of Bonn Foundation (e.g. its annual report). Your data will be processed, used and stored electronically and, from time to time, in another suitable form.

The data will be processed based on the signed funding agreement in accordance with Art. 6 para. 1 sentence 1 letter b of the EU General Data Protection Regulation (GDPR).

The personal data collected from you will be erased or blocked as soon as the purpose for which it was stored no longer applies. Storage can extend beyond this point if European or national legislatures have made provision for this in EU regulations, laws or other provisions to which the controller is subject. The data will also be blocked or erased if a storage period stipulated in the abovementioned provisions expires, unless further storage of the data is required for conclusion or performance of a contract.

3. Disclosure of data to third parties

Your personal data will only be shared with third parties insofar as this is required for the performance of the funding agreement. This includes, in particular, the processing of the financial aspects of the scholarship by the University of Bonn's budget team as well as work done by an external tax consultant. The third parties may only use the data disclosed to them for the purposes indicated.

4. Data subject rights

You have the following rights:

- If you have given consent, the right to withdraw your consent at any time in accordance with Art. 7 para. 3 GDPR by notifying the University of Bonn Foundation. This will result in the data processing that was based on this consent no longer being permitted.
- The right to demand information on your personal data processed by the University of Bonn Foundation in accordance with Art. 15 GDPR. In particular, you can demand information on the following:

- The processing purposes
 - The category of personal data
 - The categories of recipients to whom the personal data has been or will be disclosed
 - The planned storage period or, if specific information cannot be provided in this regard, the criteria applied to determine it
 - Your rights to rectification, erasure, restriction of processing, and to object
 - Your right to lodge a complaint
 - The source of your data if it was not collected by the University of Bonn Foundation
 - Whether automated decision-making, including profiling, takes place, plus relevant detailed information in this regard
- With respect to your personal data stored at the University of Bonn Foundation, the right to demand rectification of inaccurate personal data or the completion of incomplete personal data without delay in accordance with Art. 16 GDPR
 - The right to demand erasure of your personal data stored by the University of Bonn Foundation in accordance with Art. 17 GDPR. This does not apply if continued storage of the data is necessary:
 - For processing required for exercising the right of freedom of expression and information
 - For compliance with a legal obligation to which the controller is subject
 - For reasons of public interest
 - For the establishment, exercise or defense of legal claims
 - For archiving purposes in the public interest, scientific or historical research purposes or statistical purposes in accordance with Art. 89 para. 1 GDPR insofar as the erasure of the data is likely to render impossible or seriously impair the achievement of the objectives of that processing
 - The right in accordance with the conditions specified in Art. 18 GDPR to demand restriction of the processing of your personal data
 - The right in accordance with the conditions specified in Art. 20 GDPR to demand a copy of the personal data that you have provided to us in a structured, commonly used and machine-readable format or to demand transmission of that data to another controller, and the right to lodge a complaint with a supervisory authority in accordance with Art. 77 GDPR, without prejudice to any other administrative or judicial remedy
